RELEASE OF LIABILITY FOR SKI AREAS

PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

I understand that skiing and snowboarding, are **INHERENTLY DANGEROUS**, and involve risks, dangers and hazards that may cause **SERIOUS PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE** and that injuries are a common and ordinary occurrence. Risks include, but are not limited to, changes in terrain, weather and snow surfaces, ice, moguls, bare spots, rocks, stumps, debris, fences, posts, trees, lift equipment and towers, surface lifts, light poles, signs, buildings, roads and walkways, rails, boxes, table tops, other jumps and other terrain features (including their approaches and the angle of their take-off ramps, and landing areas both in and out of terrain parks), padded and non-padded barriers and obstacles, snowmaking, snow grooming, snowmobiles, collisions with other persons and other natural and manmade hazards, and **I ASSUME ALL RISKS**. I acknowledge that the risks in the sport of alpine skiing can be greatly reduced by taking lessons, abiding by the Skier Responsibility Code (known as Your Responsibility Code), and using common sense.

In consideration for participation in Blizzard Ski and Snowboard School for this season, **I RELEASE AND HOLD HARMLESS and AGREE NOT TO BRING ANY ACTION OR SUIT AGAINST all SKI AREAS** as follows: Afton Alps, Andes Tower Hills, Buck Hill, Buena Vista Ski Area, Chester Bowl, Coffee Mill Ski Area, Detroit Mountain Recreation Area, Elm Creek Winter Recreation Area, Giants Ridge, Hyland Hills Ski Area, Lutsen Mountains, Mount Itasca, Mount Kato, Mount Ski Gull, Powder Ridge, Spirit Mountain, Welch Village and Wild Mountain, its owners, officers, shareholders, agents and employees (collectively "SKI AREAS") from any liability resulting from any personal injury to myself, including death, or damage to my property which is caused by **NEGLIGENCE, STRICT LIABILITY, or BREACH OF ANY EXPRESS OR IMPLIED WARRANTY** of any SKI AREA in the design, location, construction, inspection, maintenance or repair of the conditions on or about the premises or ski area or the operations of any SKI AREA.

Nothing in this release should be construed as waiving any claims I may have for conduct that constitutes greater than ordinary negligence pursuant to Minn. Stat. § 604.055.

In the event that I am signing as a parent (or legal guardian) of a minor, I represent that I have full authority to do so, realizing that this Release is binding upon the minor as well as myself.

I further agree to **DEFEND, INDEMNIFY AND HOLD HARMLESS SKI AREAS** from any and all claims, demands, losses, damages and liabilities, contribution or otherwise with respect to **personal injury, death or property damage arising from my or a minor** on whose behalf I signed, participation in all activities at SKI AREAS. I promise not to sue SKI AREAS and further agree that if anyone is physically injured or property is damaged while I am engaged in any activity at SKI AREAS I will have no right to make a claim or file a lawsuit against SKI AREAS. I agree to defend and indemnify SKI AREAS for any and all claims, including subrogation and/or derivative claims brought by any third party or insurer, which I may cause.

I HAVE CAREFULLY READ THIS RELEASE OF LIABILITY, HAD THE OPPORTUNITY TO ASK QUESTIONS ABOUT THIS RELEASE OF LIABILITY, AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS RELEASE OF LIABILITY, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE SKI AREAS.
